

Consider the potential for enhancing the care of pregnant women who have Substance Use Disorders (SUDs) by adding Doulas to the care team

# Why look at specialized treatment for pregnant women with SUDs?

- Medical point of view
  - Improve outcomes for mother and baby
    - Increase prenatal care
    - Decrease risks to fetus/neonate
    - Decrease risks to mother
  - Decrease cost of care
  - Improve future outcomes for family
- SUD Treatment point of view
  - Pregnancy can be a time for major life changes: Recovery
  - More resources available during pregnancy: Priority population
  - Desire to do the best thing for the baby can be highly motivating

### **Barriers for Pregnant Women with SUD**

- Stigma: Addict, "using while pregnant"
- Fear: baby will be taken if anyone knows about the substance use
- Systemic racism: Not being heard by providers, lack of power in interactions
- Cultural ignorance on the part of providers/systems
- Social Determinants of Health
  - Access to services including online resources
  - Health literacy, etc.
  - Transportation

### How can Doulas help?

- Direct relationship with the woman and family: What does she want for her birth experience?
- Offer "non-clinical emotional, physical and informational support before, during and after birth" (citation below)
- A voice when needed
- Translation/explanation as needed and desired
- Proven improvement in maternal and child health outcomes

### **Doulas for People with SUDS**

- Recruit from the communities being served
- Provide Doula training leading to certification
- Provide SUD training to understand the neurobiology of addiction
- Lived experience can be incredibly helpful
- Recovery Coach training consideration
- Partnerships with medical and treatment providers with clear recognition of the knowledge and expertise that the Doula brings to the person being served

### **Barriers to Doula Care**

- Reimbursement: Not covered by Medicaid in Wisconsin
- Not covered by private insurance
- Varying levels of understanding and acceptance by medical providers
- Varying levels of understanding and acceptance by treatment providers
- Too few people in rural areas can self-pay to make this a viable "job"
  - Generally available only through grant funded project or private pay
  - Lack of access follows the Social Determinates of Health fault lines

- Doulas with SUD specialization available for any pregnant woman with SUD who wishes to have the service
- Medicaid coverage at a rate that supports agency employment of Doulas
- Doula involvement with Medical/Treatment teams providing care for pregnant women with SUDs to support early referral and on-going interaction during the perinatal period
- Active recruitment and training/support to certification for community members of the communities being served by any agency/provider
- Improved outcomes including maternal/child health AND birth experience for the women and families being served
